The Mid Shore Regional Council held a scheduled quarterly meeting on September 17, 2015. This meeting was our annual field trip, prior to leaving on the tour the meeting was held aboard the tour bus at the MSRC office. Larry Porter, President, Caroline County Commissioners; Kim Kratovil, Senator Ben Cardin's Field Representative; and Bill Miles, Executive Director, Association of Forestry Industries, met us later during the tour.

Chairman Chase called the meeting to order at 9:13 a.m. at which time introductions were made. Mr. Warner announced Chairman Chase was carrying Delegate Chris Adams' proxy. Mr. Warner also stated that he was in possession of electronic votes from Ricky Travers, Jeannie Haddaway-Riccio, and Allen Nelson who could not attend in person due to other obligations.

Approval of June 11, 2015 Minutes

The first order of business was to obtain approval of the June 11, 2015 minutes. Mr. Fuchs made a motion to approve the minutes presented, Mr. Franklin seconded the motion. Chairman Chase asked for any further discussion, all in favor to signify aye, those opposed are afforded the same rights, ayes have it. Motion carried unanimously.

Treasurer's Report

MSRC Treasurer Kurt Fuchs stated the MSRC is right on track, nothing to point out, expenditures and receivables are right where they should be. Being no questions Mr. Franklin made a motion to accept, Ms. Spicher seconded the motion. Chairman Chase asked for any further discussion, all in favor to signify aye, those opposed are afforded the same rights, ayes have it. Motion carried unanimously.

<u>Updates</u>

Eastern Shore Entrepreneurship Center (ESEC)

ESEC Executive Director Mike Thielke was present to give updates although not able to attend the tour. He stated that ESEC has a new branding, using *hotDesks – Your Link to the Innovation and Startup Ecosystem*. The new website is <u>www.hotdesks.org</u>. He stated hotDesks locations now include Easton, Salisbury, and Pocomoke City. He further noted that hotDesks and ETC Baltimore have a reciprocity agreement for their respective members. hotDesks serves as a satellite facility for TEDCO field representatives and has entrepreneurs-in-residence. As a Member of Maryland Business Incubation Association (MBIA), Mike Thielke is the MBIA Board of Director's Secretary.

Mr. Thielke has been actively assisting in the establishment of an investor club – PinOak Capital Investment Group. PinOak Capital Investment Group has individual accredited investors. ESEC will manage the fund.

Eastern Shore Manufacturing Council (ESMC)

Mr. Warner stated that Bill Barnes resigned as the ESMC Executive Director as he has taken a job as a manager at an incubator associated with Purdue University in Indiana. On August 20, 2015 the ESMC held a Board of Directors meeting to restructure the ESMC with the recent announcement of Mr. Barnes resignation. Dan McDermott, Mike Thielke and Scott Warner were added to the Board at that meeting. The current Board now is David Landsberger, Dan McDermott, Mike Thielke and Scott Warner. Once the ESMC secures funding the Board will be reconstituted with all manufacturing representatives.

<u>State Funding – FY2017</u> MSRC/regional councils Rural Maryland Prosperity Investment Fund

Mr. Warner stated that on August 14, 2015 the Director of Intergovernmental Affairs Jeannie Haddaway-Riccio facilitated a meeting between the RMC Executive Committee and representatives of the Governor's staff. RMC members in attendance were Scott Warner, Chair; Doris Mason, 1st Vice Chair; Josh Hastings, 2nd Vice Chair; Mike Pennington, Past Chair; and Charlotte Davis, Executive Director. Governor's staff present included David Brinkley, Secretary, Dept. of Budget and Management; Joe Bartenfelder, Secretary, Dept. of Agriculture; and Michael Gill, Secretary, Dept. of Business and Economic Development; and representatives from the Governor's Legislative Office. The meeting was to discuss the funding of the regional councils and Rural Maryland Prosperity Investment Fund (RMPIF). The regional councils need to reach full funding of \$200,000 per year and RMPIF funding of \$6 million per year.

Mr. Warner stated that the meeting was very positive. The regional councils and RMC will follow up as needed in the coming weeks.
